Bibliography On Demand Service

Background

The Central Reference Library, Kolkata (CRL) serves as the National Bibliographic Agency of the country and operates as a subordinate office under the Ministry of Culture (MoC), Government of India. The institution is overseen by a librarian who also acts as the general editor of its publications. Its core mission revolves around the compilation and publication of the Indian National Bibliography, a definitive record of books published in 14 different languages of India, including English. This authoritative bibliography is based on books received at the National Library under the Delivery of Books Act, 1954.

However, it is essential to note that the CRL is not a conventional library where books are stored and made available to readers. Instead, it operates primarily as a publication unit dedicated to curating the Indian National Bibliography, which serves as a valuable and comprehensive resource for scholars, researchers, and bibliophiles seeking information on published works across the country.

CRL operating under the auspices of the Ministry of Culture, is poised to expand its user base through the introduction of Bibliographic Services on Demand (BoD). This forthcoming service aims to provide users with meticulously curated lists of reliable sources compiled by professional bibliographers. By offering accurate and high-quality reference materials, the BoD service seeks to enhance the efficiency and utilization of available resources. Leveraging its reputation for premier reference services and commitment to knowledge preservation, the CRL seeks to strengthen its position as a leading hub for researchers, academic institutions, and individuals in search of reliable information through this service. Information would be drawn from the libraries that fall under the ambit of the Delivery of Books and Newspapers (Public Libraries) Act, 1954, the four libraries specified are:

- 1. The National Library, Kolkata
- 2. The Delhi Public Library, New Delhi
- 3. The State Central Library, Mumbai
- 4. The Connemara Public Library, Chennai

These libraries are entitled to receive copies of all books published in India, under the provisions of the Delivery of Books Act, 1954. The act aims to ensure that important publications are available to the public and preserved for future generations by depositing copies in these designated libraries.

Objectives

Bibliographic Services on Demand is being introduced with the following objectives:

1. Efficiency: Streamlines the process of searching and organizing relevant sources, saving time, and ensuring accuracy and quality. It enhances the CRL's commitment to supporting research, promoting intellectual pursuits, and contributing to India's cultural and educational development.

2. Efficacy of existing resources: Serves as a research support tool, helping researchers discover new sources, explore perspectives, and ensure comprehensive and reliable references for their projects in a cost-effective manner.

3. Generation of bespoke resource catalogues: Offers customization options, catering to the unique requirements of each requester. Users can choose specific citation styles, fields of study, and source preferences, ensuring bibliographies catering to individual requirements.

4. Accessibility: Provides convenience and accessibility to users from various backgrounds and locations and provides an opportunity to access a curated list of sources without the need for extensive searching.

- e. All in one service provider: Due to the comprehensive database and rigorous methods being used to generate bibliographies, the BoD service will serve as an all-in-one service provider, greatly facilitating ease in doing research.

Procedure

- 1. Applications will be accepted via the application form available on the CRL's website.
- 2. Applications will be open for acceptance from the 1st to 5th of every month.
- 3. The CRL will form a committee to assess the viability of requests in the applications received every month.
- 4. The service will be launched on pilot basis for a duration of six months and upon completion of the same, operational modalities will be reviewed in March 2024.
- 5. This service will be chargeable in nature. The monthly/yearly fee and the mode of payment shall be decided by the committee.
- 6. The guidelines and application format will be available at CRL website and regularly updated.
- 7. The first iteration of the request will supply a total of 50 books in the bibliography, the same can be availed at a nominal fee.

Timeline

The service will be launched in three subsequent phases: Phase I: Bibliography Phase II: Bibliography and Journals Phase III: Bibliography, Journals and E-resources

Review and Feedback

- 1. Post the completion of Phase I, the data collected by the CRL will be made available on its website.
- 2. A review will be conducted by CRL and MoC after completion of each phase at the time of financial year end.
