dated the 3rd. August 1910, regarding the attempt made to assassinate Babu Kamalesh Chandra Deb Roy, uncle of the Raja of Naldanga, in the Jhenida sub division of the Jessore district.

I am now to report that the police have closed the enquiry into the case, as they have failed to trace the culprit. The Sub Divisional Officer of Jhenida has ordered the case to be entered as true under section 307 I.F.C. The Lieutenant Governor does not regard the case as being of a political character and no further action regarding it will be taken.
