



## NOTICE.

The Bengal and Madras Service Family Pension Fund which is provisionally managed and assisted by Government has for its object the provision of monthly pensions for the maintenance of the widows and children of subscribers and is open, with certain exceptions, to all active and pensioned members of the Uncovenanted Service of Government (except those serving under the Government of Bombay) and to Local Fund servants earning pensions from Government. Some of the special features of the Fund are (1) that widowed daughters incapable of remarriage or children labouring under such mental or bodily infirmities as incapacitate them from earning their livelihood or preclude the possibility of marriage (in case of a daughter) are admitted to its benefits ; and (2) that subscribers to the Widows' and Daughters' branches are entitled to a refund of 30 per cent. of the premia paid, should the nominees predecease them after 5 years of admission. The Fund is now of ten years' standing and has a balance of over three and half lacs with Government on four per cent. interest. For forms of applications and rules of the Fund apply to the Comptroller, India Treasuries, Imperial Secretariat Buildings, Calcutta.
