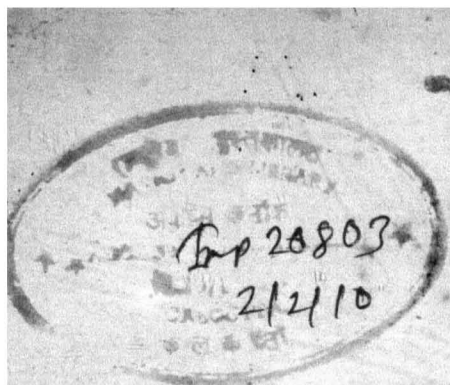

PREFACE.

THE present edition (Twenty-third of the new series) contains the History of Services, corrected up to 1st July 1912, of all Gazetted Officers (including P. W. D. Officers), whose names appeared in the latest Civil List of the United Provinces.

2. The record of each officer's service contains particulars of personal qualifications, such as college degrees, membership of societies or orders, and also the names of any literary works (official or semi-official) that he is known to have produced. Any further information on this subject should be communicated to the Accountant-General not later than the 31st May 1913 for insertion in the next edition.

3. Under orders of the Government of India in the Home Department, the War Services of all officers have been omitted; but a note has been made of the grant of a Medal or Clasp for Military or War Services to any officer.

4. Under the orders of the Government of the United Provinces, the names of Indian officials have been spelt in the manner in which they have been shown in the Civil List of the United Provinces corrected up to 1st July 1912.

5. Any mistakes or omissions noticed in this edition should be communicated to this office, in order that the next edition may be as complete and accurate as possible.

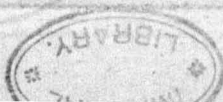
