

## PREFACE.

THE present edition (twenty-ninth of the new series) contains the History of Services, corrected up to 1st July 1918, of all Gazetted Officers whose names appear in the latest Civil List of the United Provinces.

- 2. The record of each officer's service contains particulars of personal qualifications, such as University degrees, membership of societies or orders, and also the names of any literary works (official or semi-official) that he is known to have produced. Further information on this subject should be communicated to the Accountant-General not later than the 31st May, 1919, for insertion in the next edition.
- 3. Under the orders of the Government of India in the Home Department, the War Services of all officers have been omitted; but a note has been made of the grant of a Medal or Clasp for Military or War Services to any officer.
- 4. Under the orders of the Government of the United Provinces, the names of Indian officials have been spelt in the manner in which they have been shown in the Civil List of the United Provinces corrected up to 1st July, 1918.
- 5. Any mistakes or omissions noticed in this edition should be communicated to this office.
