APPENDIX.

Orders with regard to the compilation of the History of Services.

No. 30, dated Simla, the 19th June 1886.

With reference to Lord Randolph Churchill's Despatch No. 82 (Public Records), dated the 12th November 1885, on the subject of annual publication in England of an "India Office List," similar in general principles to the Colonial and Foreign Office Lists, we have the honour to transmit, for your Lordship's information, a copy of the instructions which we have issued to Local Governments and Administrations in the Bengal Presidency, and to the several Departments of the Government of India, to ensure the correct preparation and punctual transmission to the India Office of the "Histories of Services of Gazetted Officers" published in this country, from which it is proposed that the "India Office List" should be compiled.

2. In the fourth paragraph of the Despatch cited above Lord Randolph Churchill intimated that, in addition to the information contained in the Histories of Services published in India, it was intended to give particulars in the "India Office List" of any literary work of a public or official character undertaken by any officer; and His Lordship desired that steps might be taken to obtain the required information on this point. In regard to this matter, enquiries have been made by some officers as to the meaning to be attached to the phrase "literary work of a public or official character," and to these enquiries we do not feel in a position to give a definite answer. It is doubtful, for instance, whether the term "literary work" should be held to include papers written by Government officers on such subjects as tobacco, vanilla, lac and other economic products, or such publications as the Codes of the Financial and Account Departments, or whether it should be restricted to works of a more original character, such as "Hunter's Imperial Gazetteer of India," and the manuals published by Mr. Baden-Powell.* It has also been questioned whether the term is intended to cover "Papers" and similar documents written for various associations and scientific societies, or translations as opposed to original works. As doubts have been raised on the point, and as it is desirable that the practice should be the same in the case of the India List as in that of the proposed "India Office List," we shall be glad if your Lordship will supply us with further information as to the nature, &c., of the works, particulars regarding which should be incorporated in the lists in question.

No. 67 (Public Records), dated India Office, London, the 26th August 1886.

From—Her Majesty's Secretary of State for India,

To—His Excellency the Right Honourable the Governor-General of India in Council.

I have received your Excellency's letter, Home Department, Public, No. 30 of the 19th June last, in which you ask for some further definition of the literary works "of a public or official character" which it is desired to insert in the new "India Office List" against the names of their respective authors. It is most undesirable to increase unnecessarily the bulk of the book, and it would be out of the question to include all departmental or official reports drawn up by officers. The mention of these should be limited to reports of special importance which have been deemed of sufficient interest for general publication. Other works should, generally speaking, be limited to original publications.

APPENDIX

Extract from the Proceedings of the Government of India in the Home Department (Establishments), under date Simla, No. 1-Establishments 376 to 392, the 23rd June 1890.

RESOLUTION.

In June 1889 the Comptroller-General, with a view to saving the duplication of work which results from the maintenance of the service registers in Account Offices as well as the History of Services of Gazetted Officers, recommended that the service registers should be abolished and that the Histories of Services, prepared on a uniform plan and in a condensed tabular form, should take the place of the service registers. He also proposed that those histories should be invariably prepared in the Account Office. Local Governments and Administrations were asked for their opinions on these proposals, and to advise whether there was any advantage in retaining entries regarding privilege leave and temporary acting promotions.

2. The replies of Local Governments and Administrations read in a preamble show a general consensus of opinion that the History of Services should in future be prepared in the Account Office and in a tabular form. The Governor-General in Council accepts this view and directs that the histories be in future prepared in the form appended to this resolution.

3. The general opinion is that only privilege leave taken since an officer's last return from furlough need be shown in the histories. This view has the concurrence of the Government of India.

4. Though there is some difference of opinion with regard to the entry of acting appointments, the view most generally accepted is that an acting promotion which involves a change of duties should be shown, but the grade promotions should be omitted. This view appears to the Governor-General in Council to be reasonable, but inasmuch as the histories include a notice of the services of all Gazetted Officers in Civil Departments, it cannot be brought into practice without some modification. While therefore, the appointment of an Assistant Magistrate and Collector, or of an Assistant Engineer, 2nd grade, to officiate as a Joint Magistrate and Collector, or an Assistant Engineer, 1st grade, should not be entered, it will be desirable in the case of members of the services which, like the Financial and Educational Departments, consist mainly of grades, the duties of which are not separate and distinct, to enter all acting promotions.

5. Particulars of literary works should be entered in notes at foot of the tabular statements. This information will have to be specially supplied to the Account Offices by officers who have produced literary works, and a note requesting them to communicate such intelligence to the Account Office should be prefixed to each history. The Government of the Punjab is of opinion that the numbers and dates of any official letters in which officers have received the special thanks of Government or the Secretary of State should be added as foot-notes, and that the tabular statement should show in italics appointments to and promotions in orders, such as C. S. I., C. I. E., and C. M. G. The Governor-General in Council fears that it would be very difficult to distinguish between ordinary and special commendations, and considers that it would be preferable to omit mention of them altogether, lest the bulk of the histories should be unnecessarily increased. Information in regard to the different orders should, as suggested by the Punjab Government, be given in italics.

6. The Punjab Government has hitherto provided for the inclusion in the histories for that province of information showing (a) the place of education and academical degree, if any, in the case of European and Eurasian officers; (b) caste, tribe, home of the family if in India, and academical degree, if any, in the case of native officers. There is no objection to the inclusion of this information in the histories for that or any other province in which the Local Government or Administration considers it desirable, but no other additions to the information contained in them should be made without the approval of the Government of India.
