HOUSE OF LORDS.

Die Jovis, 30° Martis, 1933.

Message from the Commons that they have come to the follow Resolution to which they desire the concurrence of this House viz. : That, before Parliament is asked to take a decision upon proposals contained in Command Paper 4268, it is expedient that a Joint Select Committee of Lords and Commons, with power to call into consultation representatives of the Indian States and of British India, be appointed to consider the future government of India and, in particular, to examine and report upon the proposals in the said Command Paper : The said message to be taken into consideration on *Tuesday* next.

REPORT

By the Select Committee of the House of Lords appointed to join with the Select Committee of the House of Commons, with power to call into consultation representatives of the Indian States and of British India, to consider the future government of India and, in particular, to examine and report upon the proposals contained in Command Paper 4268.

Ordered to Report :—

That the Committee have met and have called into consultation twenty-seven delegates from the Indian States and from British India with whom they have held more than seventy meetings. Many of these meetings have been devoted to discussion between the delegates and the Committee. In addition, over one hundred and twenty Witnesses have been examined. The Secretary of State for India has given evidence on nineteen occasions and has been questioned both by members of the Committee and by delegates.

The Committee have been unable to complete the inquiry. They recommend, therefore, that the work should be continued by a Joint Committee to be appointed in the forthcoming Session.

The Committee have ordered the Minutes of Evidence, with Appendices, and Records together with the Proceedings of the Committee to be laid before both Houses of Parliament.

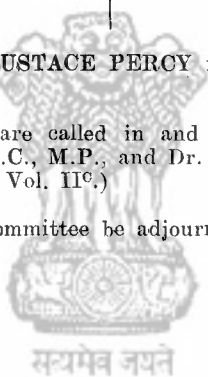
